WHEREAS, on February 23, 2026 at 10:18 AM, Bids and Awards Committee Meeting was held for the opening of the quotation of the supplier;

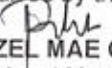

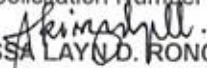
NOW, THEREFORE, we, the Members of the Bids and Awards Committee hereby **RESOLVE**:

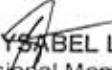

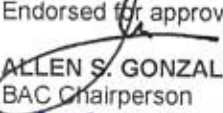

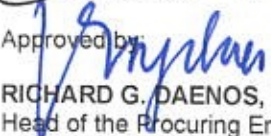
