RESOLUTION RECOMMENDING AWARDING OF THE CONTRACT TO TIES THAT TRAVEL INC. FOR THE PROCUREMENT OF SERVICES OF A GROUND HANDLER OR EVENTS MANAGEMENT COMPANY FOR THE TOURISM RECOGNITION OF ENTERPRISES AND STAKEHOLDERS (TRES) AWARDS 2025

WHEREAS, on February 27, 2026, the Request for Quotation (RFQ) for the Procurement of Services of a Ground Handler or Events Management Company for the Tourism Recognition of Enterprises and Stakeholders (TRES) Awards 2025 with an Approved Budget for the Contract (ABC) amounting to Seven Hundred Sixty-Two Thousand Pesos (Php 762,000.00) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) with Reference No. 12816908;

WHEREAS, as of 12:00 NN of March 6, 2026 posted deadline for submission of quotations, one (1) supplier, Ties That Travel Inc., has submitted quotation and documentary requirements;

WHEREAS, on March 6, 2026 at 2:10 PM, Bids and Awards Committee Meeting was held for the opening of the quotation of the supplier;

WHEREAS, upon careful examination, validation, and verification of all the Eligibility, Technical and Financial documents submitted, it was found that Ties That Travel Inc. was compliant with all the documents specified in the RFQ;

NOW, THEREFORE, we, the Members of the Bids and Awards Committee hereby **RESOLVE**:

To declare **TIES THAT TRAVEL INC.** as the sole supplier with complete submission of requirements specified in the Request for Quotation with the bid price of **Seven Hundred Fifty-Nine Thousand Pesos (Php 759,000.00)** for the contract, Department of Tourism – Region III Security Services, per PHILGEPS Ref. No. 12816908; and
2. To recommend to the Head of the Procuring Entity the approval of the award of the said Contract to **TIES THAT TRAVEL INC.** with its quotation of **Seven Hundred Fifty-Nine Thousand Pesos (Php 759,000.00)**.
