The Chairperson informed the committee that one (1) supplier has signified interest to submit quotation prior to the June 22, 2026 deadline for the **PROCUREMENT OF SERVICES OF A GROUND HANDLER/TOUR OPERATOR FOR THE 4TH CENTRAL PHILIPPINES TOURISM EXPO (SECOND POSTING)** with an Approved Budget for the Contract (ABC) amounting to **Four Hundred Thousand Pesos (Php 400,000.00)**.

In front of the quorum, the Technical Working Group opened the submitted quotation of the sole supplier, Amega Travel and Tours Services, with a submitted quotation of Four Hundred Thousand Pesos (Php 400,000.00).
