Having established the quorum, the Chairperson called the meeting to order at 9:35 AM.

The Chairperson informed the committee that two (2) suppliers have signified interest to submit quotation prior to the March 11, 2026 deadline for the PROCUREMENT OF SERVICES OF A MARKETING/ADVERTISING AGENCY OR EVENTS MANAGEMENT COMPANY FOR THE INFLUENCER MARKETING AND DIGITAL MEDIA AMPLIFICATION with an Approved Budget for the Contract (ABC) amounting to Four Hundred Thirty-Five Thousand Pesos (Php 435,000.00).

In front of the quorum, the Technical Working Group opened the submitted quotation of the suppliers, LMS Events Management Services, with a submitted quotation of Four Hundred Thousand Pesos (Php 400,000.00); and Brandjester Events Management Service, with a submitted quotation of Four Hundred Twenty Thousand Pesos (Php 420,000.00). Upon initial review of the technical requirements submitted, it was found that LMS Events Management Services failed to submit a filled-out and notarized Omnibus Sworn Statement (OSS), while Brandjester Events Management Service has complied with and has submitted all the documentary/technical and financial requirements.

After deliberation and review of all documents submitted by the proponent, the Committee has resolved to award the contract to **BRANDJESTER EVENTS MANAGEMENT SERVICE** for being the supplier compliant with the documentary and financial requirements and in consideration of its track record in rendering service in previous functions.

There being no other comments from the BAC and there being no other bids to be read and clarification to be made.

The meeting was adjourned at 10:25 AM.
