RESOLUTION RECOMMENDING AWARDING OF THE CONTRACT TO AMEGA TRAVEL AND TOURS SERVICES FOR THE PROCUREMENT OF SERVICES OF A GROUND HANDLER/TOUR OPERATOR FOR THE 4TH CENTRAL PHILIPPINES TOURISM EXPO

WHEREAS, on June 16, 2026, the Request for Quotation (RFQ) for the Procurement of Services of a Ground Handler/Tour Operator for the 4th Central Philippines Tourism Expo with an Approved Budget for the Contract (ABC) amounting to Four Hundred Thousand Pesos (Php 400,000.00) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) with Reference No. 37410;

WHEREAS, as of 7:30 AM of June 22, 2026 posted deadline for submission of quotations, one (1) supplier, Amega Travel and Tours Services, has submitted quotation and documentary requirements;

WHEREAS, on June 22, 2026 at 8:07 AM, Bids and Awards Committee Meeting was held for the opening of the quotation of the supplier;

WHEREAS, upon careful examination, validation, and verification of all the Eligibility, Technical and Financial documents submitted, it was found that Amega Travel and Tours Services was compliant with all the documents specified;

NOW, THEREFORE, we, the Members of the Bids and Awards Committee hereby **RESOLVE**:
