RESOLUTION RECOMMENDING AWARDING OF THE CONTRACT TO RED ROOT ARTISTS AND ARTISANS MULTIPURPOSE COOPERATIVE FOR THE PROCUREMENT OF SERVICES OF A MARKETING/ADVERTISING AGENCY OR EVENTS MANAGEMENT COMPANY FOR THE DESTINATION MARKETING VISUAL ASSETS PRODUCTION

WHEREAS, on February 23, 2026, the Request for Quotation (RFQ) for the Procurement of Services of a Marketing/Advertising Agency or Events Management Company for the Destination Marketing Visual Assets Production with an Approved Budget for the Contract (ABC) amounting to Two Hundred Eighty Thousand Pesos (Php 280,000.00) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) with Reference No. 12801386;

WHEREAS, as of 12:00 NN of March 11, 2026 posted deadline for submission of quotations, two (2) suppliers, Red Root Artists and Artisans Multipurpose Cooperative and Brandjester Events Management Company, have submitted quotation and documentary requirements;

WHEREAS, on March 16, 2026 at 9:35 AM, Bids and Awards Committee Meeting was held for the opening of the quotation of the suppliers;

WHEREAS, upon careful examination, validation, and verification of all the Eligibility, Technical and Financial documents submitted, it was found that both suppliers were compliant with all the documents specified. However, Red Root Artists and Artisans Multipurpose Cooperative has the lowest calculated bid;

NOW, THEREFORE, we, the Members of the Bids and Awards Committee hereby **RESOLVE**:

1. To declare **RED ROOT ARTISTS AND ARTISANS MULTIPURPOSE COOPERATIVE** as the winning supplier with complete submission of requirements specified in the Request for Quotation with the bid price of **Two Hundred Seventy-One Thousand Pesos (Php 271,000.00)** for the contract, Procurement of Services of a Marketing/Advertising Agency or Events Management Company for the Destination Marketing Visual Assets Production, per PHILGEPS Ref. No. 12801386; and
2. To recommend to the Head of the Procuring Entity the approval of the award of the said Contract to **RED ROOT ARTISTS AND ARTISANS MULTIPURPOSE COOPERATIVE** with its Quotation of **Two Hundred Seventy-One Thousand Pesos (Php 271,000.00)**.
