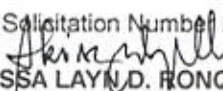
NOW, THEREFORE, we, the Members of the Bids and Awards Committee hereby **RESOLVE**:

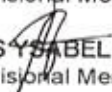

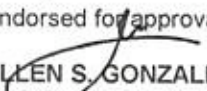
