RESOLUTION RECOMMENDING AWARDING OF THE CONTRACT TO BRANDJESTER EVENTS MANAGEMENT SERVICE FOR THE PROCUREMENT OF SERVICES OF A MARKETING/ADVERTISING AGENCY OR EVENTS MANAGEMENT COMPANY FOR THE INFLUENCER MARKETING AND DIGITAL MEDIA AMPLIFICATION

WHEREAS, on February 23, 2026, the Request for Quotation (RFQ) for the Procurement of Services of a Marketing/Advertising Agency or Events Management Company for the Influencer Marketing and Digital Media Amplification with an Approved Budget for the Contract (ABC) amounting to Four Hundred Thirty-Five Thousand Pesos (Php 435,000.00) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) with Reference No. 12801331;

WHEREAS, as of 12:00 NN of March 11, 2026 posted deadline for submission of quotations, two (2) suppliers, LMS Events Management Services and Brandjester Events Management Company, have submitted quotation and documentary requirements;

WHEREAS, on March 16, 2026 at 9:35 AM, Bids and Awards Committee Meeting was held for the opening of the quotation of the suppliers;

WHEREAS, upon careful examination, validation, and verification of all the Eligibility, Technical and Financial documents submitted, it was found that Brandjester Events Management Service has complied with all documentary requirements;

NOW, THEREFORE, we, the Members of the Bids and Awards Committee hereby **RESOLVE**:
