RESOLUTION RECOMMENDING AWARDING OF THE CONTRACT TO SNEAKERS SYNDROME SUPPLY FOR THE PROCUREMENT OF SERVICES OF A MARKETING OR ADVERTISING AGENCY FOR THE PRODUCTION OF TOURISM MARKETING COLLATERALS

WHEREAS, on February 12, 2026, the Request for Quotation (RFQ) for the Procurement of Services of a Marketing or Advertising Agency for the Production of Tourism Marketing Collaterals with an Approved Budget for the Contract (ABC) amounting to Two Hundred Ninety Thousand Pesos (Php 290,000.00) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) with Reference No. 12779878;

WHEREAS, as of 12:00 NN of February 20, 2026 posted deadline for submission of quotations, one (1) supplier, Sneakers Syndrome Supply, has submitted quotation and documentary requirements;

WHEREAS, on February 23, 2026 at 10:18 AM, Bids and Awards Committee Meeting was held for the opening of the quotation of the supplier;

WHEREAS, upon careful examination, validation, and verification of all the Eligibility, Technical and Financial documents submitted, it was found that Sneakers Syndrome Supply was compliant with all the documents specified;

NOW, THEREFORE, we, the Members of the Bids and Awards Committee hereby **RESOLVE**:
