**RESOLUTION RECOMMENDING AWARDING OF THE CONTRACT TO SYNTHESIS DIGITAL ADVERTISING SERVICES FOR THE PROCUREMENT OF SERVICES OF AN ADVERTISING AGENCY FOR THE DOT REGION III SOCIAL MEDIA MANAGEMENT**

**WHEREAS**, on February 12, 2026, the Request for Quotation (RFQ) for the Procurement of Services of an Advertising Agency for the DOT Region III Social Media Management with an Approved Budget for the Contract (ABC) amounting to Five Hundred Forty Thousand Pesos (Php 540,000.00) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) with Reference No. 12779887;

**WHEREAS**, as of 12:00 NN of February 18, 2026 posted deadline for submission of quotations, one (1) supplier, Synthesis Digital Advertising Services, has submitted quotation and documentary requirements;
