The Chairperson informed the committee that two (2) suppliers have signified interest to submit quotation prior to the February 20, 2026 deadline for the PROCUREMENT OF SERVICES OF A MARKETING/ADVERTISING AGENCY OR EVENTS MANAGEMENT COMPANY FOR THE STAGING OF FOOD TALKS 2026 with an Approved Budget for the Contract (ABC) amounting to Eight Hundred Ninety Thousand Pesos (Php 890,000.00).

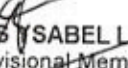
In front of the quorum, the Technical Working Group opened the submitted quotation of the suppliers, Brandjester Events Management Service, with a submitted quotation of Eight Hundred Eighty-Five Thousand Pesos (Php 885,000.00), and Total Exhibit Expo Solutions, with a submitted quotation of Eight Hundred Ninety Thousand Pesos (Php 890,000.00). Upon initial review of the technical requirements submitted, it was found that both suppliers complied with and submitted all the documentary/technical requirements. However, Brandjester Events Management Service has a lower bid price compared to Total Exhibit Expo Solutions.

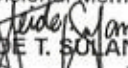

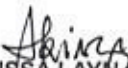
There being no other comments from the BAC and there being no other bids to be read and clarification to be made.

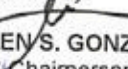
