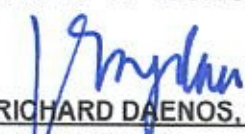
WITNESSETH: That

IN WITNESS WHEREOF THE PARTIES affixed their signatures this 23rd day of June 2026 in Clark Freeport Zone, Pampanga.

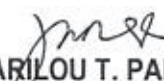

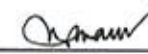
